Purpose

The purpose of this plan is to promote environmentally responsible and efficient waste management and minimisation within all areas of Marlborough Airport.

Marlborough Airport Limited is committed to total waste reduction and effective management and minimisation of Waste. Marlborough Airport Limited is committed to working in accordance with the Marlborough District Council Waste Management and Minimisation Plan.

Marlborough Airport Limited recognises that its operations have an environmental impact through emissions to air and water and the generation of waste and is committed to reducing the environmental impacts of its business.

Responsibility

This environmental policy applies to all of Marlborough Airport Limited's operations landside and airside. It is role of the Airport Management to ensure that the policy is implemented and its aims and objectives are met.

Resources

Marlborough Airport Limited will ensure that resources are available to enable it to achieve its objectives and targets.

Goals and targets

Waste Management and Minimisation:

- Reduce the harmful effect of waste.
- Minimise the amount of waste produced for eventual disposal.
- Encourage all Airport tenants and stakeholders to minimise and manage waste in accordance with this Plan.
- Increase the amount of diverted material collected from Terminal and Car Park recycling bins.
- Review waste collection contracts to ensure contractors sort and dispose of waste to ensure maximum recycling of appropriate material.
- Improve the efficiency of resource use.

Energy Consumption reduction:

- Minimise the use of floor and ceiling heating.

- Retrofit lighting with energy efficient alternatives as part of the Airport Terminal repairs & maintenance programme.
- Install environmental systems such as appropriate sensors in any development projects.
- Encourage all Airport tenants and stakeholders to minimise and manage energy use in accordance with this Plan.

Marlborough Airport Limited will further aim to increase efficiency of operations through:

- Regular review and tendering of service contracts.
- Proactive maintenance.
- Environmentally conscious procurement systems including:
 - Identifying goods or services with the highest environmental impact and mitigating impact through reduction of their use and/or using more environmental alternatives.
 - Cutting costs by improving efficiency and reducing consumption.
 - Sourcing supplies which are environmental or eco-friendly.
 - Introducing environmental requirements into tenders and contracts.
 - Dealing with old equipment correctly e.g. electrical and computer waste.

Monitoring and Reporting Progress

The progress of the Environmental and Waste Management Plan will be monitored through the monthly Management Meetings of Marlborough Airport Limited

Management will monitor the effectiveness of the Environmental and Waste Management Plan by the collection of data from the following sources:

- Waste Removal Contractors' monthly statistics.
- Energy bills.
- Energy Audits.
